### Terms of Reference

- Ensure compliance with the provisions of the Regulations as prescribed by the UGC and AICTE as well as the provisions of any law for the time being in force concerning ragging
- Work proactively and prevent any incidents of ragging within and outside the campus.
- Organize awareness programs and campaigns in IIST regarding ragging and the importance of a ragging-free environment. These programs should also emphasize the legal consequences and penalties associated with ragging as per the UGC and AICTE regulations.
- Monitor and oversee the performance of the Anti-Ragging Squad
- Investigate and take timely appropriate action on any incident related to ragging, in accordance with the relevant laws and institute regulations.
- Ensure proper counselling and emotional support to students in need.
- Prepare regular reports on its activities and the status of ragging prevention and elimination within the IIST campus. These reports will be submitted to the institute administration for review and necessary actions.
- Make timely recommendations for policy improvements and changes to strengthen the anti-ragging measures in place at IIST.
